Hello and happy 2026, CCREDC investors and stakeholders!

2025 was a busy one for the organization, and we are proud of the work our team has done to forward our mission to bring jobs and investment to the Coastal Bend.

The opening of the new Harbor Bridge and working to secure new water sources for our region will position our area for strategic growth in the coming years, and we are looking forward to capitalizing on the opportunity to increase the wealth of our region, bring opportunities to our residents, and increase the economic stability of the Coastal Bend.

Lack of water is the biggest threat to our growth and to our existing industry and local businesses. We have a lot of work to do. We still need to bring all of the water sources online in the timeline expected to avoid curtailment.



This doesn't mean that we will sit idle. Using the recommendation of the 2025 Targeted Industry Survey we are focusing on those industry sectors that do not require a lot of water to operate such as light manufacturing, medical devices, and aerospace defense which includes drones. We are implementing our new marketing plan which includes reaching out internationally to specific countries like the United Kingdom and Germany. Both countries have invested billions in the US and are expected to continue to invest. Our strategy extends out three to four years where we start looking west to Japan and South Korea.

Our team is working with other organizations in the coastal bend on workforce training for manufacturers through

Texas Manufacturing Assistance Center (TMAC), and Texas Defense Aerospace Manufacturing Community (TDAMC). These relationships which include Del Mar College, Texas A&M University – Corpus Christi, Workforce Solutions of the Coastal Bend, Craft Training Center, Texas A&M University – Kingsville, Education Service Center #2, and local ISDs. We need all of us to reach as many manufacturers as possible and students and residents ready to learn and ready to work in industry. We will be ready with a workforce that can quickly fill the jobs of the projects that will come when we have water again.

Our commitment to bringing new jobs and investment to our region manifests in the continued success of our local economy- our average wage continues to maintain its peak near the Texas average which we met for the first time since 1986 in October of 2023 and we have surpassed our all-time high of 200,000 jobs and we have kept that level.

Thanks for your support of our efforts to grow the Coastal Bend economy- here's to more exciting things to come in 2026!

CCREDC Type B Small Business Support

The City of Corpus Christi B Corporation (Type B) collects 1/8th percent sales tax. This began in 2018 when City Council passed Type B to replace the Type A economic sales tax that helped pay for Whataburger Field as well as many Type A business incentives and affordable housing. Type B funds are divided between economic development projects (50% of funds), \$500,000 annually for affordable housing, and all remaining funds to streets that are designated arterials and collectors.

CCREDC has provided staffing for both the Type A and now Type B Board since its inception. To apply for funds, prospective projects start by filling out an EDC application for incentives. If the application meets eligibility requirements, it would next be presented to the CCREDC Board of Directors for consideration of approval/disapproval to the Type B Board. The application is then presented to the Type B Board for possible approval of the grant and agreement. Last, the agreement would be sent to the City Council for allocation of the grant money.

In 2025, The Type B provided funding for eight Small Business Assistance Programs. These small business assistance programs include: internships programs that match students at both Del Mar College and Texas A&M University-Corpus Christi with small businesses to work as interns, Service Corps of Retired Executives for mentoring small businesses, LiftFund (a micro-lender for those companies having trouble getting business loans from small banks), Del Mar College government procurement Apex Accelerators, large business procurement center called CRC, the Small Business Development Center business counselors, and the Cyber Center.

Each of these agreements require that the EDC completes the compliance required before any money is paid out by the City.

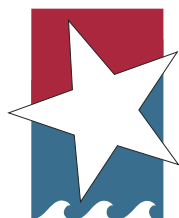
